OUR HISTORY

The organisation that is now known globally as 'QA International Certification Limited', commenced in 1992, when founders Alan Carter and Alf Duffield combined their strengths, to establish what was always intended to be an 'International' Certification business.

The Directors believed in 'the value of certification' from the beginning. Carter with a Corporate Plc Board level background and extensive knowledge of Quality Assurance gained from the Ministry of Defence (AQAP) and Nuclear Industries, and Duffield as a past Commercial Director with 'Vickers Defence', and who was still reeling from the 'Oil Crash' of the 80's, as past Chairman and founder of ITM Offshore, a Company that became a major Teesside employer.

The ten-year period between 1992 and 2002 heralded in many of the overseas partners that QAICL still has in its International network of offices today, and also saw the transition of its accreditation provider, from the quasi-civil service of NACCB, to the non-profit-distributing UKAS, whose role is now enshrined within law as the UK's approved accreditation provider. QAICL's structure also includes QAIC (Packaging) Ltd incorporating the previous IHC Ltd as share-holding partner and a newly launched Training Division.

As a forerunner to the establishment of QAIC (Packaging) Ltd and before BRC had conceived its own Certification Standards, QAICL provided assessment and registration to its own Standards for Packaging and Hygiene, under codex alimentarius. This was administered through a

specialist and very well respected Technical Audit Management Company 'IHC Ltd', founded by Peter Ainsworth and Brian Fowler and which originally provided assessment services to The Royal Society of Health. The partnership continues to this day, whereby QAICL and IHC staff combine over 80 Years of Codex - Food Safety and hygiene, knowledge & experience, which is reflected in the day to day management and operations of QAIC (Packaging) Ltd.

QAIC (Packaging) Ltd is now headed up by John Hartley, one of its Directors and owners.

Increasing in numbers of staff year on year for the past five years, its customer base continues to grow, and partnerships with some major blue-chip companies have helped to develop the company into one of the leading certification providers in the Packaging and Storage & Distribution industry.

QA International Certification Limited reaches its 25th Anniversary in the month of October 2017, the Directors are currently working on a medium to long term plan to restructure the business so that it will be in a good position for what they hope will be the next twenty-five years. To underpin this aspect, the Directors have an eye on the Company's future and its 'continuity management', through the employment of the next generation of Carters and Duffields in order that the families may carry on the business where the founders left off!

PACKAGING STANDARDS

The largest sector that QAIC (Packaging) Ltd work in is auditing against the BRC Global Standard for Packaging and Packaging Materials.

Issue 5 of the Global Standard for Packaging and Packaging Materials (the Standard) was released in July 2015, and has been audited from 1st January, 2016. Originally developed and published in 2001, it was designed to protect the consumer by providing a common basis for the certification of companies supplying packaging to food producers. The Standard has been updated at regular intervals since to reflect the latest thinking in product safety, and has now attained usage worldwide.



Benefits

Adoption of the Standard leads to a number of benefits for packaging and packaging materials manufacturing businesses.

- The Standard is internationally recognised, GFSI-benchmarked and provides a report and certification that can be accepted by customers in place of their own audits, thereby reducing time and cost
- It provides a single standard and protocol that governs an accredited audit by third-party certification bodies, allowing a credible independent assessment of a company's product safety and quality systems
- It enables certificated companies to appear in the publicly available part of the BRC Global Standards Directory, allowing recognition of their achievements and use of a logo for marketing purposes
- It is comprehensive in scope, covering areas of quality, legality and product safety
- It addresses part of the legislative requirements of the packaging manufacturer/supplier, packer/filler and retailer. Packaging manufacturers may also use this Standard to ensure their suppliers are following good manufacturing practices and are fulfilling legal requirements
- It enables companies to ensure their suppliers are following good practice in product safety
- It provides a framework for the development of quality and hygiene management systems in companies, encouraging continuous improvement, reduction in waste and increased efficiency
- It provides a range of audit options, including announced and unannounced audit programmes. These will not only satisfy customer demands, but also enable companies to demonstrate compliance through a process which best suits their operation and the maturity of their product safety and quality management systems
- It is part of a scheme offering an array of training, education and technical support.



The Standard is for manufacturers of packaging and packaging materials for food and non-food applications.

The Standard now provides a framework for all types of packaging manufacturers to assist them in the production of safe packaging materials and to manage product quality to meet customers' requirements. Certification against the Standard is recognised by many brand owners, retailers, food service companies and manufacturers around the world when assessing the capabilities of their suppliers. In response to demand, the Standard has been translated into many languages to facilitate implementation by packaging materials companies across the world.

The Standard has been developed to specify the product safety, quality and operational criteria that must be in place within a packaging manufacturing organisation in order for it to fulfil its obligations with regard to legal compliance and protection of the consumer. The format is designed to allow a company's premises, operational systems and procedures to be assessed against the requirements of the Standard.

Following a successful certification audit, and once any non conformances were satisfactorily cleared, you would then be registered with the BRC on their global Directory, allowing suppliers and customers to see that you are a BRC registered company.

STORAGE AND DISTRIBUTION

In 2006 the BRC introduced the Global Standard for Storage and Distribution to compliment the suite of Global Standards covering the production of food, packaging and consumer products.

Malcolm Logistics has worked closely with QAIC Packaging as we strive to achieve BRC certification across all UK sites by October 2017.

Adoption, use and certification to the Standard provide a number of benefits in terms of the operation of the business, customers and marketing. This Standard allows the chain of product certification to be completed, from primary processor to manufacturer, and from manufacturer to retailer (or food service company in the case of food).

Benefits

- It is an internationally recognised Standard which provides a report and certification that can be accepted by customers in place of their own audits – reducing time and cost.
- The comprehensive scope, covering areas of quality, hygiene and product safety, provides a benchmark for best practice in storage and distribution industries.
- When effectively adopted it can reduce damage, waste and therefore, costs to the business.
- It forms the basis for accredited audits providing greater credibility and recognition when certification is achieved.
